



Bacon County Student Technology Competition Parent Consent Form Information

Dear Parent(s) or Guardian:

Your child would like to participate in the Bacon County School District *Student Technology Competition* to be held on Friday, November 30, 2018. The Technology Competition is open to students in grades 3-12. The top contestants in our Fair will be eligible to compete in the *Regional Competition* to be held at South Georgia State College - Waycross Campus on January 28, 2019 from 10 a.m - 3 pm. This is a great opportunity for your student to share his/her knowledge with peers, teachers, and others. The Bacon County School System will be responsible for transportation to and from the Technology Competition.

Student Responsibilities:

1. A student may enter **only 1 category** as an individual or as a member of a team (maximum of 2 members per team) in one of the following competition categories (see www.bcraiders.com for complete descriptions):
Categories: 3D Modeling, Animation, Audio Production, Device Modification, Digital Game Design, Digital Photo Production, Graphic Design, Internet Applications, Mobile Apps, Multimedia Applications, Productivity Designs, Robotics, Video Production.

Projects are to be designed and created by students. Some adult guidance is allowed, but it must be clear that all work entered by students was done by the students.

2. All projects will be required to have a **worksheet** (submit with your project) for the judges to see. You will receive the worksheet when the parent consent form is returned.

3. The **Parent Consent** form must be returned by **Wednesday, October 24, 2018**. **Students must return a Parent Consent form (on the next page) with parent signature to be eligible to enter the Fair.** Copies of the form are on the school website in case you need a clean copy. Students entering as a team must compete at the grade level of the oldest member of the team. Teams are made up of **no more than two members**. Each member of a team must turn in an individual Parent Consent. **If a student participates as a team member, he/she may not also enter an individual project in that category.**

4. Students will present their project for judging on November 30, 2018 during the school day at Bacon County Elementary School. All registered students must attend the *Student Technology Competition*, in order to have their project judged. Student projects, if applicable, are to be burned to CD or on a USB drive and ready for presentation on arrival. If you are using particular software that is on your laptop, you will need to bring it with you to present from. The school assumes no liability/responsibility for projects/computers while at school. Judges' decisions are final.

Parents will be responsible for the following:

1. Review the detailed information on the school's website with the student to ensure the student is aware of the rules of the Technology Competition.
2. Ensure that the submitted project was designed and created by student. Some adult guidance is allowed, but it must be clear that all work entered by student was done by the student.
3. Sign the Consent Form below to give permission for the student to participate in the Technology Competition.
